## **RULES FOR THE SELECTION OF PROJECTS FOR BNEW BARCELONA START-UP INNOVATION HUB TO BE HELD IN BARCELONA FROM OCTOBER 5TH TO 8TH**

### **INTRODUCTION**

Barcelona New Economy Week – BNEW is a **physical and digital B2B** event that gathers unique events of the sectors of **Logistics, Real Estate, Digital Industry, Ecommerce, Economic Zones, Mobility, Talent, Sustainability, Science and City sectors**. They all share a common denominator: **New Economy**.

An Expert Committee will rank the projects in order to obtain a shortlist of the best solutions. The final selection will follow the rank ordering provided by the Expert Committee.
