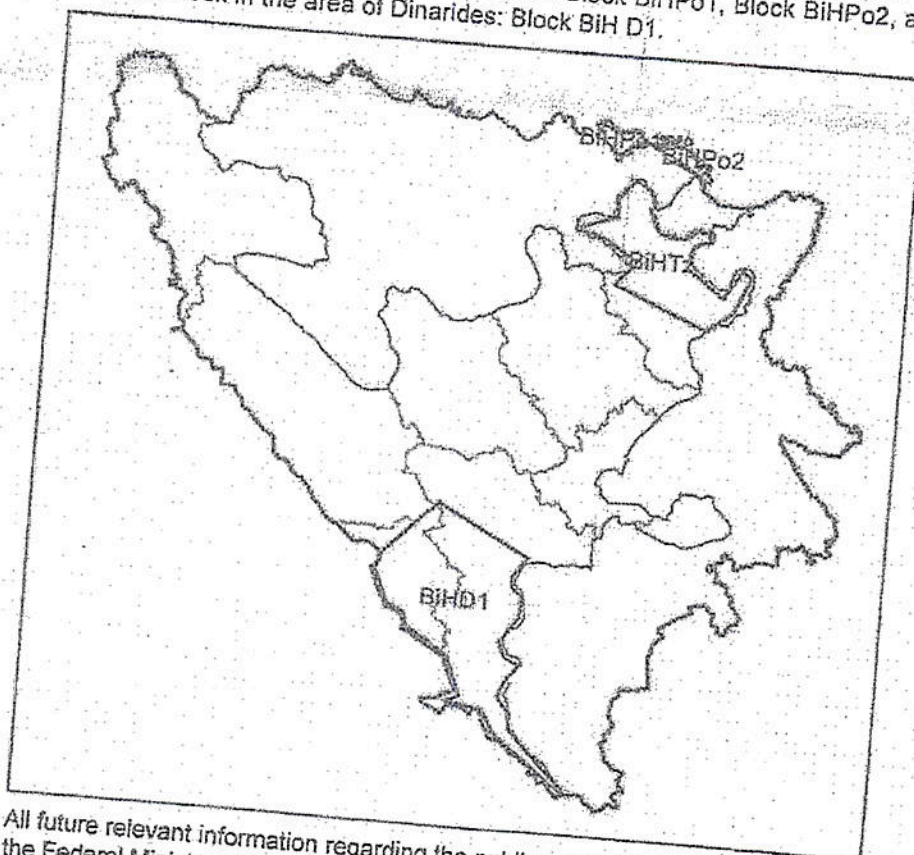

EXPLOITATION OF HYDROCARBONS IN THE FEDERATION OF BOSNIA AND
HERZEGOVINA**

Documentation of the conditions and manner of participation in the Public competition for the concession award for exploration and exploitation of hydrocarbons onshore in the Federation of Bosnia and Herzegovina is published on the websites of the Government of Federation of Bosnia and Herzegovina www.fbihvlada.gov.ba and the Federation Ministry of Energy, Mining and Industry www.fmeri.gov.ba and sent by Daily Alert service by IHS Markit and their weekly newsletter to their subscribers.

Public competition will last till 27th May 2020 shall be conducted to award a concession for exploration and exploitation through concluding a concession contract between the Government of Federation of Bosnia and Herzegovina and the Selected Bidder(s).

Area for which the public competition is announced includes four blocks. Three blocks are located in the area of the Pannonian Basin: Block BiHPo1, Block BiHPo2, and Block BiH Tz; and one block in the area of Dinarides: Block BiH D1.
